DURING THAT TIME, WE SAVED 3,132 ANIMALS FROM HIGH KILL SHELTERS THROUGHOUT SOUTH CAROLINA, NORTH CAROLINA, VIRGINIA, MARYLAND, TEXAS, MISSISSIPPI, FLORIDA, AND PUERTO RICO.
